RECOGNITION ORDER

WHEREAS, in terms of Section 14 (1) of the NCTE Act, 1993, Heeralal Singh Shiksha Avam Samaj Kalyan Samiti, Plot no.: 177/1K, Street/Road: Pathat Road, Vill.: Teonthar, P.O.: Chaukhada, Teh./Tal.: Teonthar, Town/City: Teonthar, Dist.: Rewa -486220, Madhya Pradesh (WRCAPP2634) had submitted on 26.05.2015 the application to the Western Regional Committee of the NCTE for grant of recognition to Heeralal Singh Teacher's Training College, Plot No.: 177/1k, Street/Road: Pathatroad Vill.: Chaukhada, P.O.: Chaukhada, Teh./Tal.: Teonthar, Town/City: Rewa, Dist.: Rewa -486220, Madhya Pradesh for B.A. B.Ed. & B.Sc. B.Ed. Integrated Programme.

AND WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education notified the Regulations, 2014 on 1.12.2014.

AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit, and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee in its 249<sup>th</sup> meeting held on April 21-23, 2016 is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the B.A. B.Ed. & B.Sc. B.Ed. Integrated Programme, such as, infrastructural and instructional facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

NOW, THEREFORE, in exercise of the powers vested under Section 14 (3) (a) of the NCTE Act, 1993 and in accordance with the Regulations, 2014, the Western Regional Committee, NCTE hereby grants recognition to Heeralal Singh Teacher's Training College, Plot No.: 177/1k, Street/Road: Pathatroad Vill.: Chaukhada, P.O.: Chaukhada, Teh./Tal.: Teonthar, Town/City: Rewa, Dist.: Rewa -486220, Madhya Pradesh for conducting B.A. B.Ed. Integrated course of 4 (Four) years duration with an annual intake of 50 students (one basic unit of 50 students) and B.Sc. B.Ed. Integrated Programme of 4 (Four) years duration with an annual intake of 50 students (one basic unit of 50 students) from the academic session 2016-17.

The institution shall gradually move towards becoming a composite institution as per clause 8(1) of the NCTE Regulations, 2014.

The institution shall comply with various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

The institution shall make admissions only after it obtains affiliation from the examining body in term of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

The institution shall ensure that the required number of academic staff for conducting the course is always in position.

The recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, State Government etc. as applicable.

The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with annual statement of accounts duly audited by a Chartered Accountant.

- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
